Knolls Estates Monthly Board Meeting October 20th, 2021 Approved Minutes of Meeting

The meeting was called to order by Greg Gardner @ 6:05pm

1.) Roll Call

2.) Rules of Order

The Rules of Order were read.

3.) Approval of Minutes from September 15th Meeting:

Motion was made by Tom Schaub and seconded by Mary Nordeen to approve the September 15th, 2021 board meeting minutes. It was approved by unanimous vote.

4.) **Reports from Officers and Committee Chairs:**

A.) President – Greg Gardner

- I.) Reminder: No permanent parking of vehicles allowed on the streets. There are a few homeowners who continue to park on the road continuously.
- II.) Rumble strips have been installed in Phase II where most of the complaints regarding speeding occur; 3 on Culver and 1 on Divot Lp. The rumple strips are the best option as the Association cannot afford large speed signs. Mary Nordeen asked if we can't put some on Scardi. No, it's the City's road. Michael George said the strips are supposed to last approx. 15 years. Greg said he saw one driver slow down for the bumps. Tom Schaub said we may need to purchase more.
- III.) Chuck and his crew have the proper permits and have started burning piles of brush. Greg said he sent out an email to homeowners to forewarn them of the burning. Mary Wallace commended Chuck and his crew for their efforts in getting the brush under control. She has been worried about fire danger. Greg brought up to those in attendance that offering a place to put their brush after trimming would be a good idea. Chuck Caylor said that taking brush to the dump is very expensive and can be up to \$60 a trailer load. A spot behind the Association's storage shed in common area #10 would be made for homeowners to dump their trimmings and Chuck would then burn it. Those in attendance agreed

this would be a good idea. Absolutely no grass clippings, garbage or other household items would be allowed.

- IV.) RV's, trailers, boats, utility & cargo trailers etc. If homeowners need extra time than the 48 hours (2 days), just send an email to <u>ske97479@gmail.com</u> requesting additional time and the reason and the Board will respond. For the most part, we will ok additional time if known prior. The main reason behind this, is that the Board knows what to expect should other neighbors complain.
- V.) Dri-Z-Air has been purchased for the shed to minimize the moisture as there is paperwork and decorations in the shed in addition to tools.

B.) Treasurer's Report – Tom Schaub

I.) Peggy Schaub said that October is disaster preparedness month. Greg Gardner sent out an email regarding some of the resources that are available should homeowners be looking for details on being more prepared in an emergency. Knolls Estates is an evacuation site for the City of Sutherlin in a disaster. She recommends a week worth of water and supplies. See Peggy for more details.

Tom explained that the operating loss was due to the road resurfacing projects. Overall finances of the Association are in great shape.

C.) Board Members – comments and Concerns

- I.) Greg Gardner said that the streets of Sandpiper, end of Scardi, Slazenger and Chi Chi are on the schedule to be resurphased next year. Perhaps Eagle Loop may be done as well, although that is the best street in the Association. There were too many construction projects on Scardi to resurphase that area this year.
- II.) Tom continues to keep up communications with Jerry at the City regarding the chevron signs on Dovetail Lane. The City is no longer considering fixing the speed sign that had broken earlier in the year...too expensive. However, they are anticipating 5 new radar signs with flashing lights and Tom has requested 1 to be saved for using on Dovetail Ln. The chevron signs are also still in the plans. Michael George would like to see a 40MPH sign between the golf course and Church Rd. on the highway, or possibly extend the double yellow lines. There will be an increasingly

larger number of people using this area as the housing construction continues. Mary asked if Evergreen will have 1 entrance? Yes, on Dakota St. Tom will continue to stay in contact with Jerry.

III.) Greg reports that 2 water meters were recently given out. 4 more are spoken for with the new construction. Some of the older water meters are starting to go out. The newer meters are better made.
