5.) Unfinished Business:

A. Phase 3 Leland Cypress Trees

Joe Beador reports he has not heard back from the State regarding the use of that land. He did meet with a contractor, the area to be used has a significant drop off. Tony Hamrick and Joe will be meeting again to further discuss it. Lathan Drake from 726 Slazenger is considering allowing the use of water and power from his lot and will be getting with Tony on that.

6.) **Owner Comments:**

- --Russ Mock inquired about changing the stop sign to a yield sign. He said the street is very visible. Joe Beador asked if the HOA must petition the City. Russ asked if the City owned the sign. Al Olson said the sign is on HOA property, but it protects the City street.
- --Russ Mock said Greg Goode has cleaned up the areas behind his house and wonders if he can be compensated for it since Chuck Caylor is for doing the common areas. Joe B. explained Chuck is hired for specific areas. Greg does a good job and he is a good citizen.
- --Al Olson wanted to point out the fog lines that were recently painted are peeling in some areas. The contractor hired to repaint did advise the lines were already peeling. Joe B. stated this contractor was hired only to repaint, not clean up the old. Next time it is done it will be done right so it lasts the two years. Joe B. inquired if anyone thought the street sweeper affected it. Al, Russ, and Donna all agree it does not.
- --Donna Pagel asked why there is no sign announcing the monthly meetings. Joe B. explained it didn't work. He said he puts the sign up and the same people show up. Donna is concerned the Hot Topics does not have it announced. Jennifer will consult with Kathy on that. Joe B. said he would put the sign back up.
